


# May 2019 EMS Calls By District








# May 2019 EMS Calls With Response Time Greater Than 20 Mins.






# May 2019 EMS Calls By Type


# May 2019 EMS Calls By Response Time






# May 2019 EMS Calls By Prime Unit


# May 2019 Fire Calls By District













# May 2019 Fire Calls By Type






