


# June 2020 EMS Calls By District




# June 2020 EMS Calls With Response Time Greater Than 20 Mins.


# June 2020 EMS Calls With Response Time Greater Than 20 Mins.





# June 2020 EMS Calls By Type




# June 2020 EMS Calls By Response Time


# June 2020 EMS Calls By Response Time






# June 2020 EMS Calls By Prime Unit










# June 2020 Fire Calls With Response Time Greater Than 20 Mins.



# June 2020 Fire Calls With Response Time Greater Than 20 Mins.



# June 2020 Fire Calls By Type






