



April 2023 EMS Calls By District






April 2023 EMS Calls With Response Time Greater Than 20 Mins.


April 2023 EMS Calls With Response Time Greater Than 20 Mins.






April 2023 EMS Calls By Type


April 2023 EMS Calls By Response Time


April 2023 EMS Calls By Response Time






April 2023 EMS Calls By Prime Unit




April 2023 EMS Calls By Prime Unit



April 2023 Fire Calls By District





April 2023 Fire Calls By District





April 2023 Fire Calls With Response Time Greater Than 20 Mins.





April 2023 Fire Calls With Response Time Greater Than 20 Mins.



April 2023 Fire Calls By Type




