


# January 2024 EMS Calls By District








# January 2024 EMS Calls With Response Time Greater Than 20 Mins.


# January 2024 EMS Calls With Response Time Greater Than 20 Mins.






# January 2024 EMS Calls By Type


# January 2024 EMS Calls By Response Time






# January 2024 EMS Calls By Response Time




# January 2024 EMS Calls By Prime Unit









# January 2024 Fire Calls By District




# January 2024 Fire Calls With Response Time Greater Than 20 Mins.



# January 2024 Fire Calls With Response Time Greater Than 20 Mins.






# January 2024 Fire Calls By Type


# January 2024 Fire Calls By Response Time
