


# July 2024 EMS Calls By District





# July 2024 EMS Calls By District




# July 2024 EMS Calls With Response Time Greater Than 20 Mins.


# July 2024 EMS Calls With Response Time Greater Than 20 Mins.






# July 2024 EMS Calls By Type


# July 2024 EMS Calls By Response Time


# July 2024 EMS Calls By Response Time






# July 2024 EMS Calls By Prime Unit









# July 2024 Fire Calls By District





# July 2024 Fire Calls With Response Time Greater Than 20 Mins.





# July 2024 Fire Calls With Response Time Greater Than 20 Mins.



# July 2024 Fire Calls By Type






# July 2024 Fire Calls By Response Time
