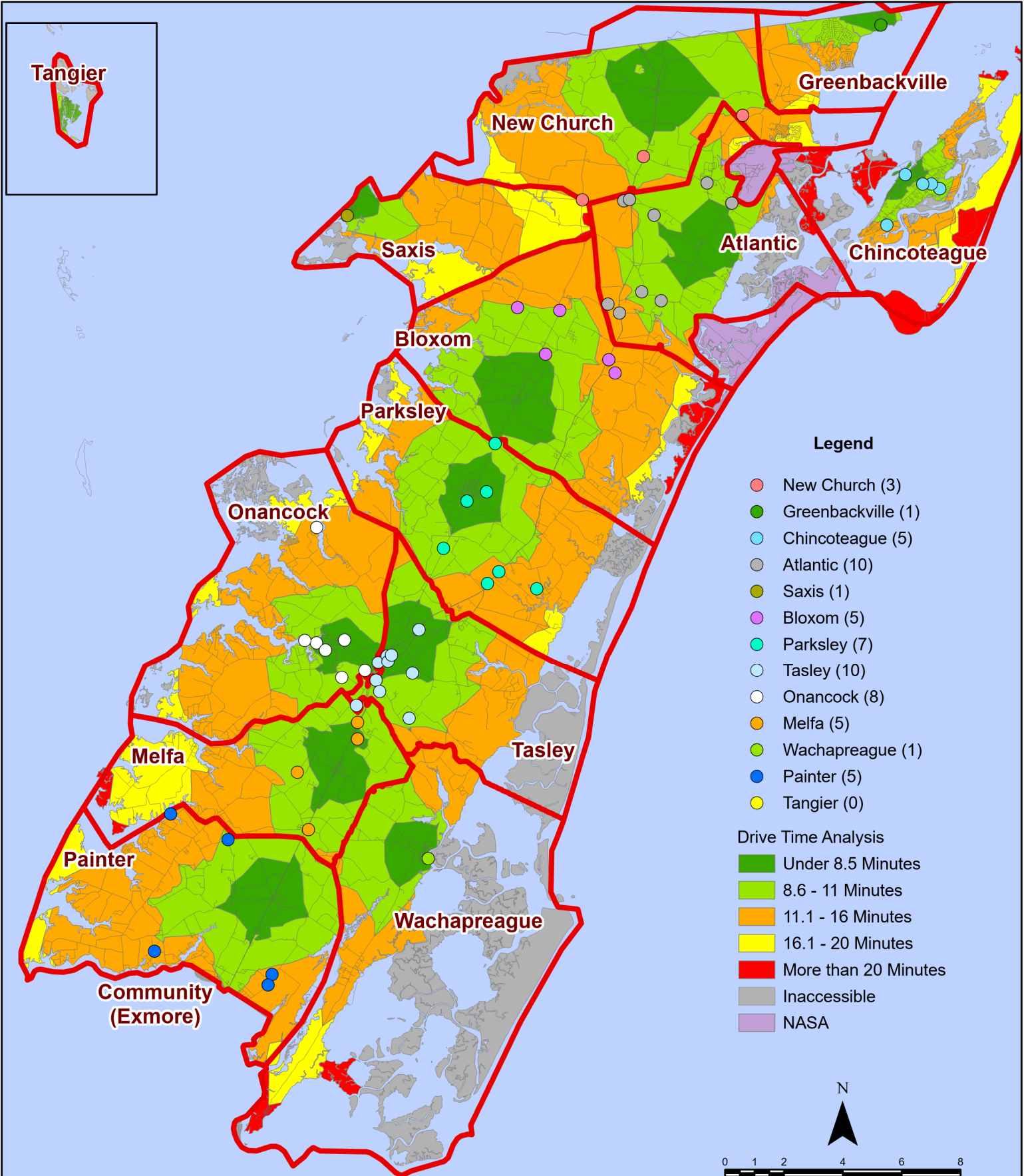

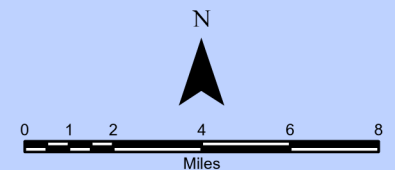

April 2025 Fire Calls By District

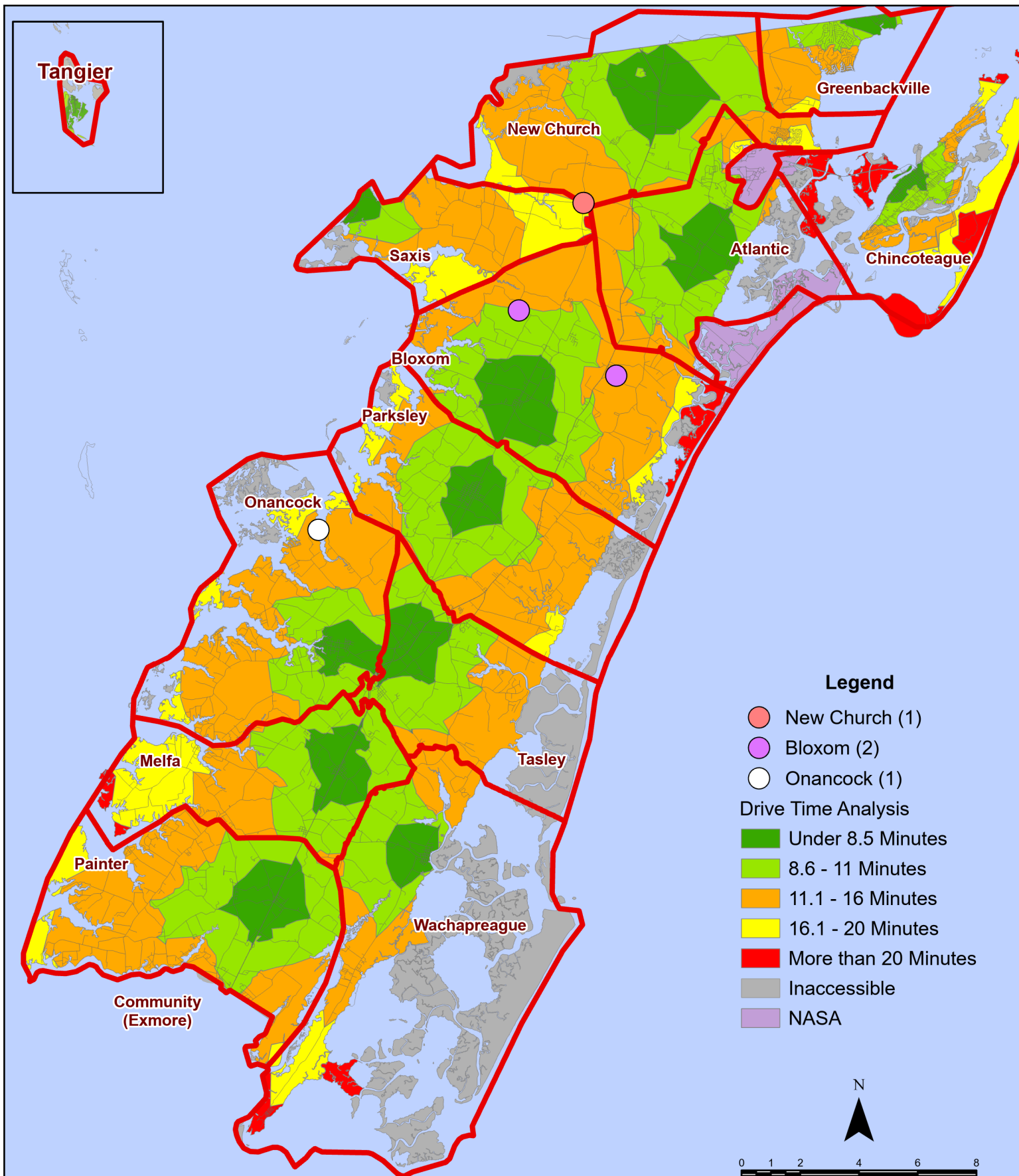

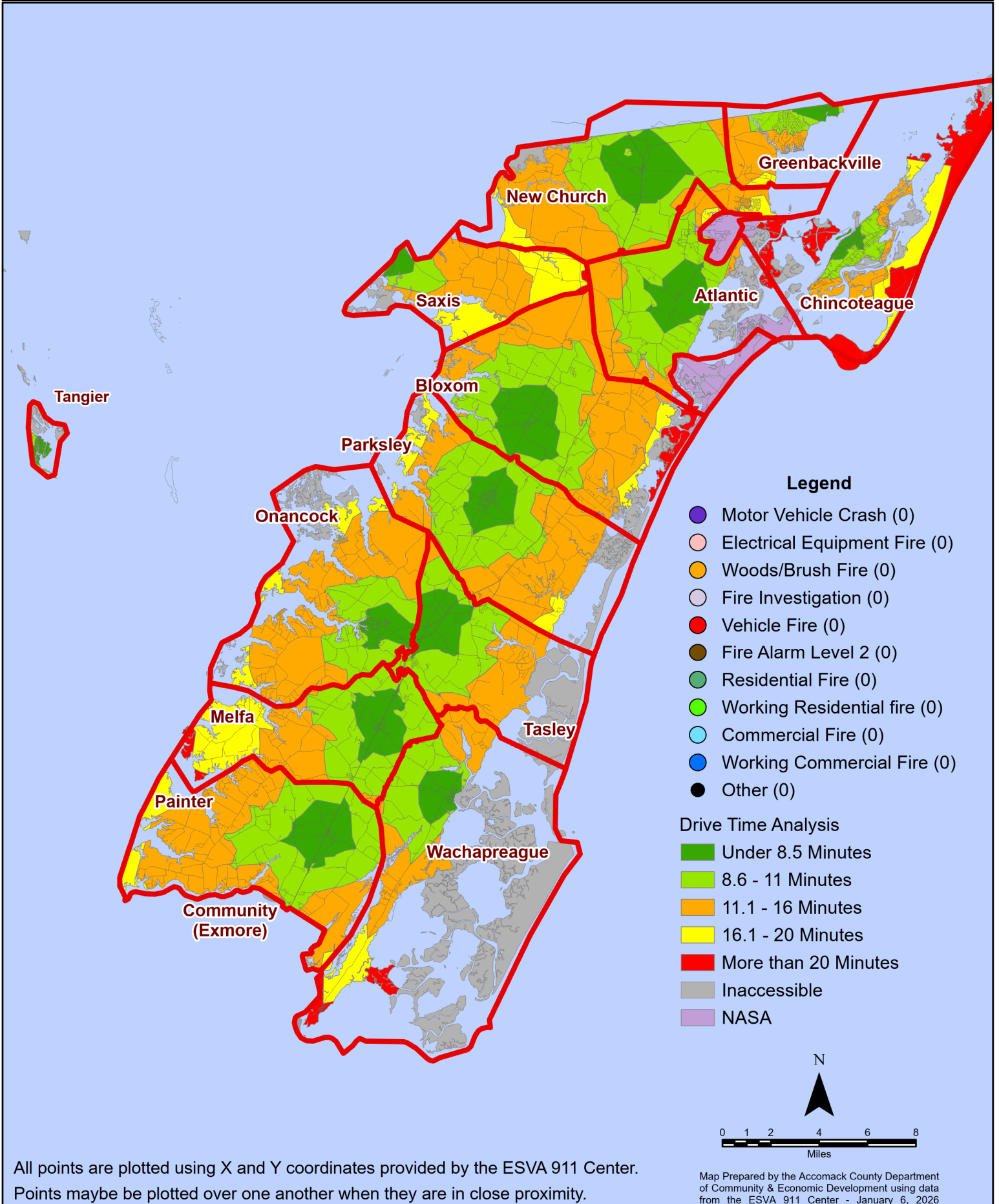

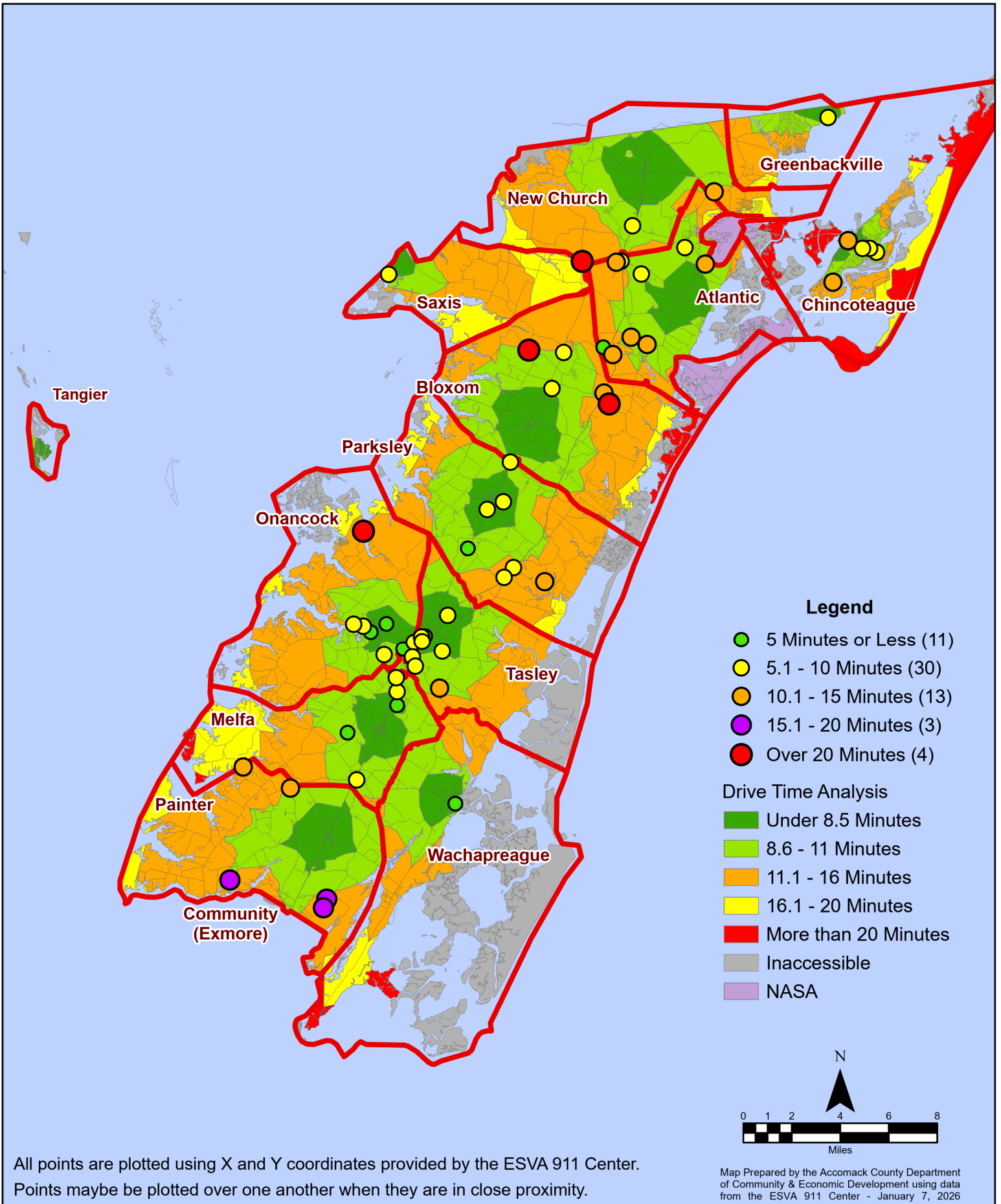
April 2025 Fire Calls By Type

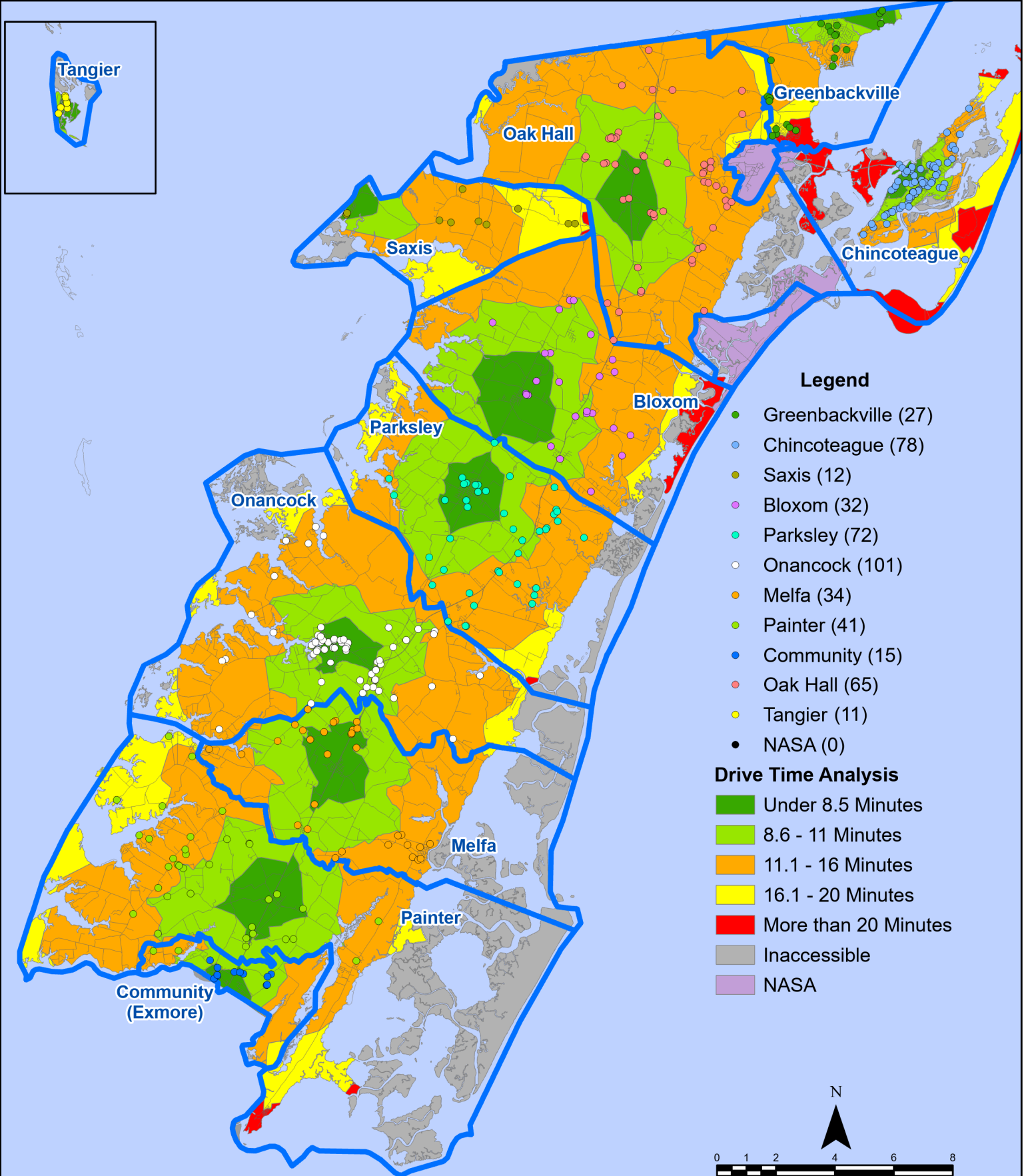
April 2025 Fire Calls By Response Time



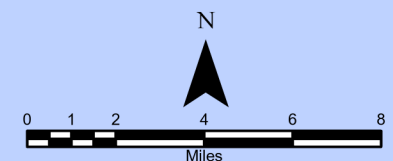

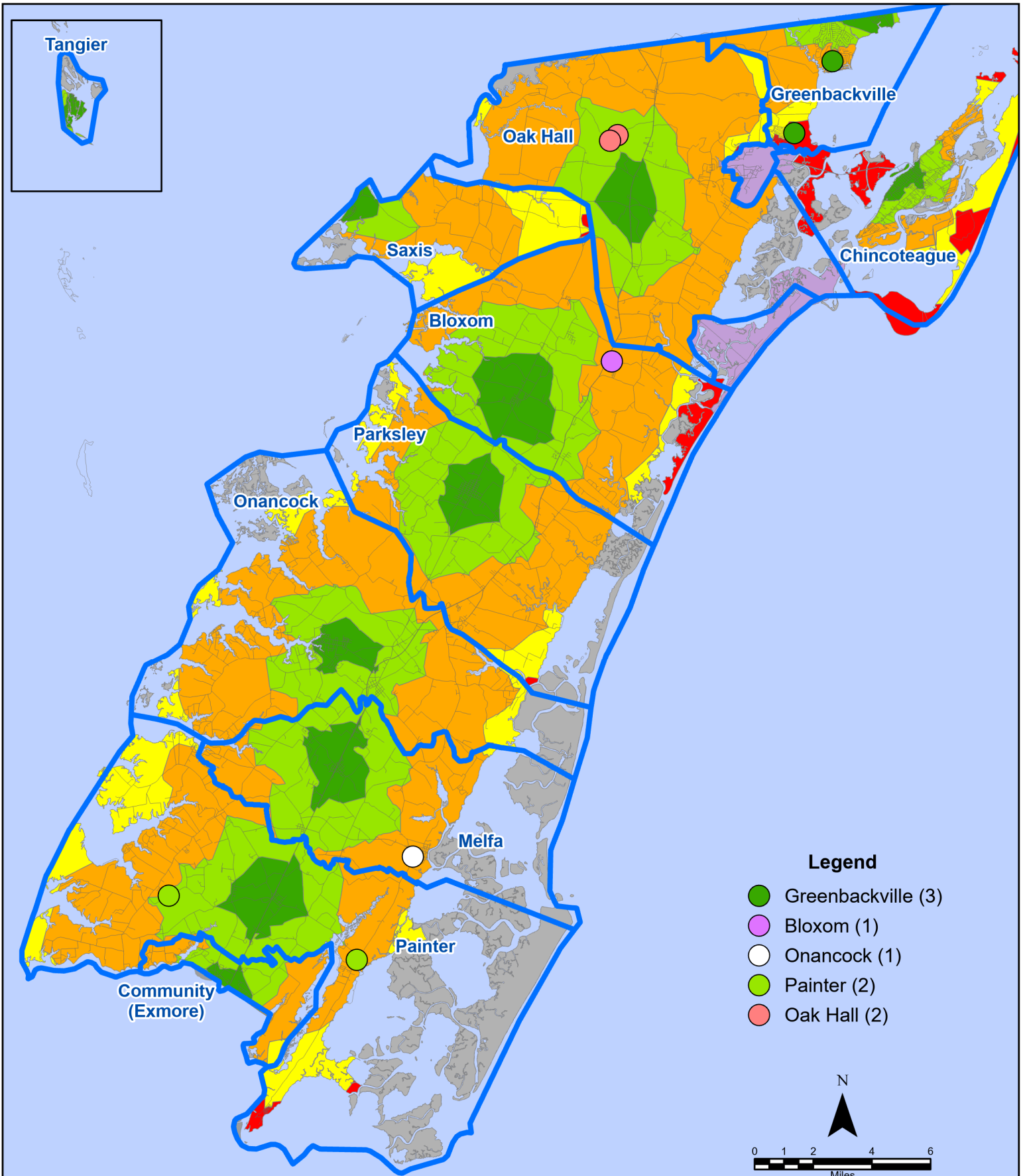

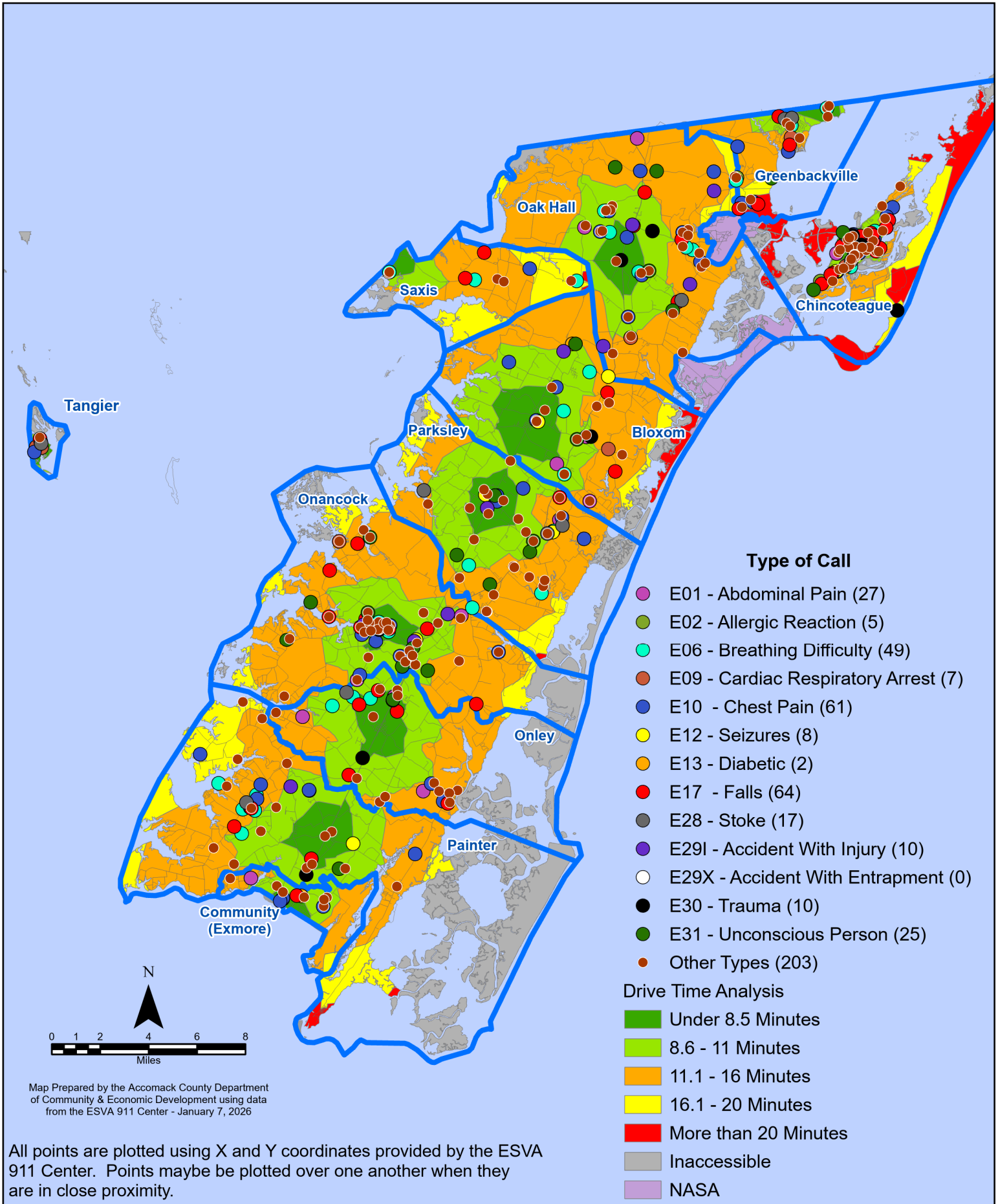
April 2025 EMS Calls With Response Time Greater Than 20 Mins.



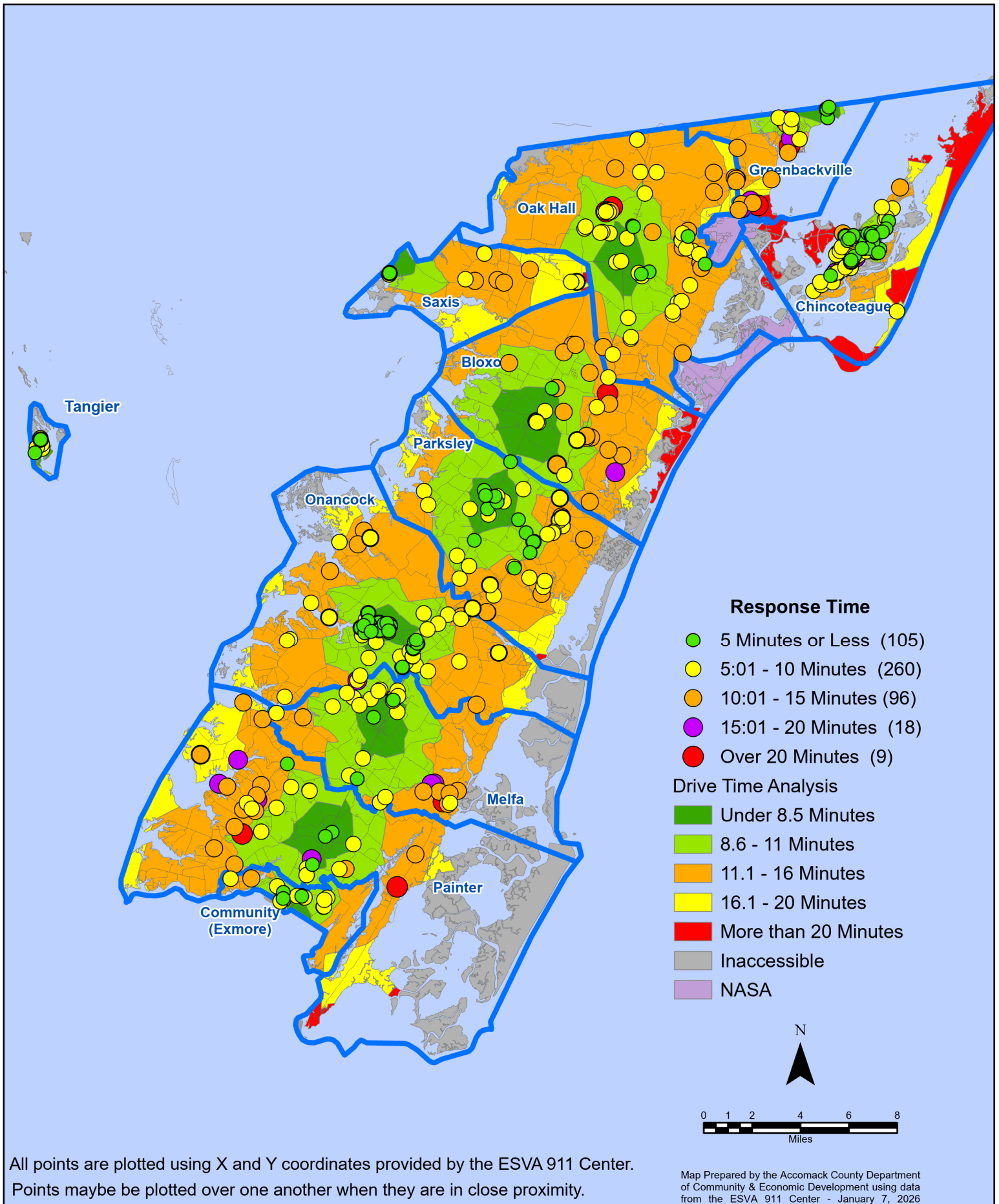
