


May 2016 EMS Calls By District









May 2016 EMS Calls With Response Time Greater Than 20 Mins.






May 2016 EMS Calls By Response Time






May 2016 EMS Calls By Type


May 2016 EMS Calls By Prime Unit


May 2016 Fire Calls By District








May 2016 Fire Calls With Response Time Greater Than 20 Mins.


May 2016 Fire Calls With Response Time Greater Than 20 Mins.


May 2016 Fire Calls By Response Time


May 2016 Fire Calls By Response Time


May 2016 Fire Calls By Type
